Terms & Conditions

1. Definitions

Foxline means Foxline Motorcycle Community, its founders, management, volunteers, ride marshals, coordinators, organisers and authorised representatives.

APEX20 means the exclusive rider selection program conducted by Foxline.

Applicant means any individual applying for APEX20.

Member means an applicant who has been officially selected.

Ride means any ride, meetup, event, training session, workshop or gathering organised or recognised by Foxline.

2. Eligibility

Applicant must

- Be at least 21 years old.
- Hold a valid driving licence.
- Ride a legally registered motorcycle.
- Carry valid insurance.
- Wear ISI/ECE/DOT certified helmet.
- Possess complete riding gear whenever required.
- Be medically fit.

Foxline may request documentary proof at any time.

3. Selection Process

Selection is completely discretionary.

Applying does not create any right to membership.

Foxline reserves the right to

- shortlist
- reject
- defer
- cancel
- terminate

any application without assigning any reason.

The decision of Foxline shall be final.

No correspondence regarding rejection shall be entertained.

4. Limited Intake

APEX20 is intentionally limited.

Foxline reserves the right to

the number of seats.

The name "APEX20" is a brand identity.

It does not legally obligate Foxline to select exactly twenty riders.

These Terms constitute the complete understanding between Foxline and the applicant regarding APEX20 and supersede prior communications relating to the program.
